COVID-19 CODE OF CONDUCT FOR ASBURY GROUP PARTICIPANTS

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. **COVID-19 is extremely contagious** and is believed to spread mainly from person-to-person contact. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, either prohibited and/or limited the congregation of groups of people.

As part of the church's effort to protect everyone who utilizes our facilities, all **members/participants of an approved Asbury Group** are required to agree to this Code of Conduct.

Please read and initial next to each of the following statements indicating your understanding and agreement. Please direct any questions to: Israel Olivieri Jr., Asbury Church Business Manager.

_____ I will wash my hands using CDC recommended handwashing procedures throughout the day.

_____ I will not enter church facilities if I have symptoms of COVID-19. Such symptoms include, but are not limited to chills, shortness of breath, dry cough, sore throat, or a fever of 100.4 degrees or higher. If I develop such symptoms, I must be symptom-free for 72 hours before returning to Church facilities.

_____ I will, AT ALL TIMES, wear a mask while on church property, and/or while engage in the approved church activity, and will remain 6 feet from all other people who are not members of my household.

_____ I will limit my exposure by complying with all federal, state, county, and local mitigation and/or prevention orders, and will follow any and all recommendations from these same authorities, that limits my risk for exposure and/or spread of the COVID virus.

_____ I will cooperate with any attempts to prevent exposure on Church facilities by permitting Church to take my temperature, if requested.

positive for COVID-19, am a presumed positive, or if I develop any of the symptoms of COVID-19 listed above.

_____ I will immediately notify: Israel Olivieri Jr., Asbury Church Business Manager, if I become aware that I was exposed to someone who has tested positive for COVID-19 or is a presumed positive.

_____ I will follow all other rules and procedures adopted by the Church to prevent exposure to COVID-19 and protect the health and welfare of the Church community.

I have read, understand, and agree to comply with the provisions listed herein. I acknowledge that failure to act in accordance with the provisions listed herein, or with any other policy or procedure outlined by the Church may result in loss of my small group participant privileges, and/or in cancellation of the approved activity with or without notice.
